### ***What is Explicit Consent?***

## **CUSTOMER CONSENT FORM FOR THE PROCESSING OF PERSONAL DATA**

### **1. General Information**

The protection and processing of your personal data shared with **GASEL Endüstriyel Alan Planlama Yönetim Proje İnşaat ve Tic. Ltd. Şti. (GASEL)** will take place within the scope of the Personal Data Protection Law No. 6698 and the relevant legislation. Within the framework of the activities carried out within the scope of the contracts, your personal data will be processed as specified in the Consent Form for the Processing of this Personal Data.

### **2. Collection of Personal Data**

Your personal data; In accordance with the provisions of the KVK Law and the relevant legislation;

- Our Suppliers,
- Our company employees and our systems,
- All kinds of information obtained from public institutions and organizations through our customers for the reasons stipulated in the laws can be collected in written, oral or electronic media with documents.

I authorize **GASEL** to collect and process my personal data in the ways described above.

### **3. Processing of Personal Data**

Your personal data and your special personal data (religion and blood group information) contained on the ID and driver's license are processed for the purpose of conducting goods and services purchase processes.

### **4. Processing of Personal Data in Case of Non-Establishment of a Contract**

### **5. The Rights that the Customer Has**

*11 Of the KVK Law. in accordance with the article, as a personal data owner, you can apply to our Company on the following issues::*

- To learn whether your personal data has been processed or not,*
- To request information if your personal data has been processed,*
- To learn the purpose of processing your personal data and whether they are used in accordance with their purpose,*
- To learn about the third parties to whom your personal data is transferred domestically or abroad,*
- To request correction of your personal data in case of incomplete or incorrect processing and to request notification of the transaction made in this context to the third parties to whom your personal data are transferred,*
- To request the deletion, destruction or anonymization of your personal data if the reasons requiring the processing of your personal data disappear, and to request that the transaction made in this context be notified to the third parties to whom your personal data are transferred,*
- To object to the occurrence of a result against the data owner by analyzing your processed data exclusively through automated systems,*
- To request compensation for the damage if you suffer damage due to the illegal processing of your personal data.*

*6. 13 Of the KVK Law. in accordance with the article, you can submit your requests regarding these rights to GASEL in writing or by other methods determined by the KVK Board.*
